## **ACBA 2020 YOUTH MANAGEMENT CONTEST**

### **PURPOSE**

To acknowledge excellence of management style by ACBA Youth Members in the areas of housing and equipment, feeding and animal care, disease control, record keeping, breeding and genetics for the care and production of cavies.

#### **RULES**

- 1. Any ACBA Youth Member is eligible to compete. Membership must be valid on March 1, 2020. Attendance at the ACBA Specialty Show is **NOT** necessary.
- 2. Application must be made from the form provided by the ACBA Youth Committee. These forms are available from the ACBA website, ACBA Youth Chairperson, and members of the Youth Committee
- 3. Applications are to be completed by the contestant and in their own words. Youth under the age of nine may choose to have some help in filling out the application.
- 4. Up to seven (7) pages, printed on one side only, of information may be submitted by the applicant. These should include information needed to complete the answers. Visual aids may be included within this page limitation.
- 5. Applications will be judged by district, and age within district; up to 9 yrs., 9-11 yrs., 12-14 yrs. and 15-18 yrs. Age is determined by age on the last day of 2020 ACBA Specialty (May 10<sup>th</sup>, 2020). A National winner and Runner-up will be selected for each age division.
- 6. Winners will be announced at the ACBA Banquet at the ACBA Specialty Show. Contestants need not be present to win.
- 7. Applications may either be submitted by **Emailing or mailing in** your contest questions as well as the ACBA 2020 Specialty Contests Entry Form, in a **Word document.** A current photograph of yourself is optional. If you are submitting a photograph electronically, please be sure it is of high resolution and clarity for a print publication (these items will need to be scanned and attached to the email). Incomplete applications or failure to follow these instructions will incur a 10-point deduction per infraction.
- 8. Do not place your name on any of your pages other than on the entry form! Placing your name on any of the Contest Question pages will result in a 10-point deduction per infraction. Mailed applications must be postmarked by March 15, 2020, emailed applications must be received by midnight (MST) May 15, 2020.

## **ACBA 2020 Management Contest Questions**

- 1. When did you join the ACBA and how many consecutive years have you belonged?
- 2. Name the breed(s) you raise, how many animals you have in each breed and why you raise these breed(s). Also, include breed(s) you have raised in the past and why you no longer raise them.
- 3. Describe where your animals are located: barn, outbuilding, garage, basement, house, etc.
- 4. How do you protect your animals from heat, cold or drafts?
- 5. Describe your cages/coops, list the number, size, materials they are made of, and how they are constructed.
- 6. Describe the equipment you use to feed and water your animals.
- 7. What type(s) of feed(s) do you give your animals? Do you give your animals feed supplements? If so, what and why?
- 8. How do you dispose of the manure and waste your cavies generate?
- 9. Describe any other equipment used for the care of the cavies in your project.
- 10. Describe everything you consider and do when breeding your animals. Include ages, time of year, system for keeping track of bred animals and provisions for pups and sows.
- 11. Describe everything you do to care for the mother and young from birth until weaning.
- 12. How many litters with how many total animals did you have born since May 1, 2019? How many young did you wean? How many litters did you lose? Do you know why?
- 13. Do you track the quality of your offspring to the breeding animals? Explain in detail.
- 14. Describe your culling procedure. What do you do with your surplus animals?
- 15. How many replacement animals have you added since May 1<sup>st</sup>, 2019? Why did you decide to add these replacement animals? What qualities do you look for in selecting replacements?
- 16. Describe any diseases that have affected your herd and explain what you did to control them. If you did not have any diseases affecting your herd, then list one disease and explain what you would do to control them.
- 17. Explain your system for keeping records and what information is kept on each animal. Please enclose an example/copy of your records.
- 18. Did your ACBA animal project show a profit or loss last year? Explain.
